### THE GERMAN WIND ENERGY MARKET

The onshore wind market in Germany is of great interest to Danish wind energy suppliers.

With almost 30,000 turbines in operation in Germany and many soon to come off the initial feed-in tariff, the market is huge.

Service, retrofitting and life extension, but also decommissioning are some of the topics that are gaining in importance in Germany, which continues to be the leading O&M market in Europe.

We invite German owners, operators and service companies to talk about their perspectives and challenges in the German onshore wind O&M market. The idea is to get a comprehensive picture from different perspectives and to bring together all parties involved in the decision making process to buy Danish services and solutions.

The format (key notes and panel session) will allow the Danish participants to influence the direction of the discussion by asking questions and presenting solutions. We are confident that this concept will enable Danish companies to present their solutions, network, make new and relevant contacts and start a dialogue about exporting services and solutions to Germany.

### PARTICIPATION FEE

Due to subsidy programs by the Ministry of Foreign Affairs of Denmark, there is a 50% subsidy for SMEs.


